## Terms

- 1. The advisors agree to provide funding for the PhD student (min. 3 years overall) according to the funding plan below.
- 2. All parties agree on the tentative exchange timeline below.
- 3. All parties agree on the graduation plan below.
- 4. It is expected that PhD students in the program will publish the results of their research in top-tier venues in machine learning-driven fields and/or in the co-advisor's associated interdisciplinary field.
- 5. It is expected that Intellectual Property (IP) generated during the research project will be arranged between the home and the exchange institution. The ELLIS Society does not claim any IP.
- 6. The PhD student agrees to spend at least 50% of their time with their primary advisor and to visit the secondary advisor (exchange partner) for a period of min. 6 months (if applicable). The partitioning of this time is flexible. If the secondary advisor work in the same university/city, they should meet regularly with the PhD student.
- 7. If applicable, the secondary advisor (exchange partner) agrees to host the PhD student for min. 6 months at their institution and provides all necessary work equipment.
- 8. If the secondary advisor is in the same university/city, encouragement is given to the PhD student to spend at least one month abroad during their thesis.

## Funding plans

Specifies tentatively who funds the PhD student during which period of time.

## Exchange timeline (if applicable)

Specifies tentatively when the PhD student will visit the exchange partner.

## Graduation plan

Specifies the institution from which a degree shall be obtained and the tentative date.

At the above-named home institution, students do not have a fixed assigned supervisor when they start their PhD, and are allowed to affiliate with a certain group or supervisor at a later point in time. This letter only expresses an offer for supervision; any party may unilaterally terminate this offer or withdraw from it. The PhD student can be admitted to the ELLIS PhD Program, but will need to meet the ELLIS requirement in terms of the advisor's role in ELLIS (i.e. co-supervision by 1 ELLIS Fellow/Scholar + 1 interdisciplinary advisor who is an ELLIS Fellow/Scholar/tenured faculty) to be able to stay in the program after they have chosen their supervisor.

#### Admission to the ELLIS PhD Program

After (1) signing this Letter of Intent and (2) being approved by the ELLIS PhD and Postdoc Committee, the PhD student will be officially admitted to the ELLIS PhD Program and will be listed on the website as an 'ELLIS PhD Student'. ELLIS has the right to retract the title 'ELLIS PhD Student' in case the conditions are not fulfilled. During their PhD, candidates are expected to fulfill the following basic requirements:

- The PhD student must publish at least one first-author paper in a top-tier venue in machine learning-driven fields: NeurIPS, ICML, ICLR, JMLR, CVPR, ICCV, ECCV, IJCV, PAMI, RSS, CoRL, ACL, EMNLP, KDD, AAAI, IJCAI, COLT, UAI, AAMAS, AISTATS, TACL, SIGIR, WSDM, or Web Conference (not including workshops). For papers published outside the Machine Learning community, such as top-tier venues in the co-advisor's research field, the target venue must be approved by the PhD Committee. Note that the list of journals and conferences will be extended by the ELLIS Board in the future.
- The PhD student must visit their co-advisor for min. 6 months or meet regularly if they work in the same university/city.

After obtaining their PhD, candidates who have fulfilled the basic requirements of the ELLIS PhD Program's Interdisciplinary Track will receive an ELLIS certificate and be listed on the Alumni page as ELLIS graduates and be offered an ELLIS membership. If the basic requirements have not been fulfilled upon graduation or completion of the appointment, the ELLIS PhD and Postdoc Committee will not award the ELLIS certificate and the student will not be listed as an ELLIS graduate, nor be offered an ELLIS membership.
